The Town Board members met at 7:00 p.m. to review and audit the monthly bills. Motion by Bayly, seconded by Bentley and carried that the bills have been audited for payment.

The public hearing on proposed Local Law #3 of 2011 entitled "Amending the Land Use Regulations and and Use District Map of the Town of Poestenkill" was opened at 7:15 p.m. The affidavit of publication was available for review. This proposed local law would amend the land use regulations and the land use district map by changing from the present zoning or R to NP the parcel of land described in maps submitted with the rezoning application of Polaro Construction filed with the Town Clerk on or about July 13, 2011. No one spoke on this local law. The actual vote will take place during the business portion of the meeting.

Public Comment Period –

Laurie Owens, new property home owner attended a meeting earlier in the year regarding new property owner tax exemption (5 yr. exemption) for new property owners who meet the criteria. Ms. Owens stated that Rensselaer County adopted the law and each town would have to adopt the law individually. Supervisor Jacangelo stated that the board would have to direct the town attorney to move forward with the legislation. Councilman Bayly wanted to know if the town board had all the criteria and Mr. Tomaselli stated that the town board members had all of the information and it was given to them earlier in the year. Board members will review the information and discuss this further at their regular January meeting. D. Basle, Fire Chief thanked the board for purchasing the flags for the water hydrants. R. Brunet, water manager will be opening/flushing the hydrants over the next few weeks and he thanked the fire company for putting up the hydrant flags. T. Jacangelo reserved time to speak. When everyone was given the opportunity to speak, Supervisor Jacangelo closed the comment period.
