The Town Board members met at 7:00 p.m. to review and audit the monthly bills. On a motion by Councilman Bayly, seconded by Councilwoman Cropsey and carried the bills were accepted for payment. Supervisor Jacangelo opened the meeting with the Pledge of Allegiance.

Public Hearing on proposed Local Law #1-2012 entitled "AMENDING THE LAND USE REGULATIONS AND LAND USE DISTRICT MAP OF THE TOWN OF POESTENKILL" was opened at 7:15 p.m. This proposed local law is to amend the area of an active mine that was in operation in 2011 by 43 Mall LTD to rezone from residential agricultural ("RA") to natural products ("NP") approximately 1.44 acres of land. No one spoke and the public hearing was closed by Supervisor Jacangelo at 7:20 p.m.

Public Comment Period - L. Basle requested time to speak when the fire company contract was being discussed and D Reis, representing the Library wanted to reserve time when the library report was given.

#### **Discussion Items**

First Time Home buyers Exemption- There was a lengthy discussion among board members regarding this exemption. Mr. Tomaselli had prepared draft legislation to enact a proposed local law. Fire Department Contract – L. Basle thanked the Town Board for the Fire Protection Agreement and everything is in the document as discussed. Motion by Bayly, seconded by Slavin and an oral vote of 4 ayes to authorize the Supervisor to sign the agreement.

Library Service Agreement – Motion by Slavin, seconded by Cropsey and an oral vote of 4 ayes authorizing the Supervisor to execute the 2012 Library Service Agreement.

Library Lease Agreement – Motion by Slavin, seconded by Bayly and an oral vote of 4 ayes authorizing the Supervisor to execute the 2012 Lease Agreement.

Veterans Agreement – Motion by Cropsey, seconded by Slavin and an oral vote of 4 ayes authorizing the Supervisor to execute the 2012 Veterans agreement.

Benefit Unit Review Board Meeting - The Benefit Review Board met on January 18<sup>th</sup> to review five requests to eliminate the benefit unit charge that is charged on a parcel of land. Out of the five requests two parcels were granted refunds. Motion by Slavin, seconded by Cropsey and an oral vote of 4 ayes authorizing the town supervisor to sign a check refunding the monies to property owner (Tax I.D. #125.-2-6) once property taxes are paid. Motion by Slavin, seconded by Bayly and an oral vote of 4 ayes authorizing the town supervisor to sign a check refunding the monies to property owner (Tax I.D. #125.-1-26) once property taxes are paid.

Park Planning – There was a lengthy discussion on the open space proposals and the board felt that both firms were reputable ones. The two firms are Saratoga Associates and Synthesis. However, Saratoga Associates is \$5,000 over budget. The board decided to leave the decision up to Supervisor Jacangelo. Motion by Slavin, seconded by Bayly and an oral vote of 4 ayes authorizing the Supervisor to choose at his discretion the firm as long as it stays within the budget allowed.

### Reports

Supervisor's Report – Supervisor Jacangelo reported on the water review board going. He is also going to invoice Jersen for some water leaks. Close-out documents are needed for Jersen. It was noted that the water systems correct as built drawings have yet to be received. Councilman Bayly stated that the system is not running the way it should be for a new system. The board decided to have R. Brunet contact C.T. Male and in turn have C.T. Male contact Casale over the water leakage problem.

Motion by Slavin, seconded by Bayly and an oral vote of 4 ayes to continue the free water meter policy through January 31, 2012.

Town Attorney's Report – Mr. Tomaselli read his monthly report which included his activities since the last town board meeting. These activities included preparation of forms regarding the Lochvue rezoning application and other documents for tonight's meeting. Full report is on file in the Town Clerk's Office.

Town Clerk's Report – Motion by Slavin, seconded by Bayly and carried to accept the Town Clerk's 2011 Revenues and Disbursements report. Motion by Slavin, seconded by Bayly and an oral vote of 4 ayes to accept the Town Clerk's report for December 2011. The amount collected in the clerk's office was \$3,778.19 and of that amount \$3614.54 was remitted to the Supervisor. Town Board members had copies of the Building Inspector/Code Enforcement/Water Manager's report, as well as the dog control report, the assessor's report, and the highway report. Also, there was a report from Creekside Kennel Ltd. – dba Animal Annex of Rensselaer County – Shelter Report. A written report from the Town Historian was also part of the town board's packets.

Supervisor Jacangelo noted that a letter was sent to County Executive Jimino in regards the town's MS4.

Motion by Slavin and seconded by Bayly and an oral vote of 4 ayes to accept Warrant #01-2012 in the amount of \$34968.99. Motion by Bayly, seconded by Cropsey and an oral vote of 4 ayes to pay Warrant #02-2012 in the amount of \$23,280.89.

Motion by Slavin, seconded by Cropsey and carried to adjourn this meeting at 8:45pm.
