Supervisor Jacangelo opened the meeting with the Pledge of Allegiance at 7 p.m. and opened the floor for public comment period. M. Hass spoke on the Supervisor's choice for Deputy Supervisor without discussing it with town board members. Supervisor Jacangelo responded by saying that the Deputy Supervisor's position is an Administrative position. He further quoted some State Laws pertaining to this position. Supervisor Jacangelo stated he had spoken to several of the board members and it was apparent to him that they were not prepared to take the position so he looked outside the town board. He went on to give some background information on Mr. Wohlleber. M. Hass stated she was interested in the process of the appointment. Supervisor Jacangelo stated that he was going to appoint who he trusted to fill the duties of the position in the best interest of the town. He said that he had asked Councilwoman Bentley. Councilwoman Bentley stated that the conversation she had with the supervisor was him saying I am assuming you are not interested in the position because of being so busy. He then went on to tell her who his choice was and she did have a problem with that and she did voice her concern to him. She felt like it was a "slap" in the face to all of the board members. Councilwoman Bentley stated that when Supervisor Jacangelo talked with her on the phone, if he had asked her than if she was interested in the position she would have accepted it. Several other residents weighed in on the situation including, E. Eisenhandler whose concern was that the appointment was a "single person's decision." He stated that his concern had no reflection on Mr. Wohlleber. Another concern of his, was that Mr. Wohlleber was not elected by the electorate. He urged one of the board members to step up and take the Deputy Supervisor's position. Councilwoman Ross feels like the board was left out of the "loop". The dialogue continued among board members and the audience and it was decided that they would take a recess and board members and Supervisor Jacangelo exited to the upstairs meeting room. At 8:40 pm, the board members along with Supervisor Jacangelo returned to the actual meeting with apologizes from Supervisor Jacangelo on the mess he had created. He realizes that it was an insult to the board and he apologizes for this. He also apologized to Mr. Wohlleber on the mess he created. He also apologized to the residents that were present at this meeting and also to the community.

Motion by Supervisor Jacangelo, seconded by Wait and an oral vote of 5 ayes to appoint Patrick Tomaselli Town Attorney at an annual salary of \$34,440.30 to be paid monthly, for normal and usual affairs of the Town. To the extent that Mr. Tomaselli performs legal services on special matters, he is entitled to and shall receive compensation at the rate of \$150 per hour plus expenses. Special matters are defined as follows: Preparation for prosecution or defense of, negotiation and settlement efforts related to and any other reasonable and necessary services in connection with any actual or threatened litigation, administrative proceeding, special proceeding or arbitration, including such matters as notices of claim, pre-litigation hearings and discovery proceedings, tax certiorari matters, administrative and judicial appeals, representation of special districts for the providing of municipal services, and such other matters as the Town Board shall from time to time determine.

Motion by Ross, seconded by Hass and an oral vote of 5 ayes to set the annual salary of the Town Supervisor, Dominic J. Jacangelo at \$16,000 to be paid monthly.

Motion by Hass, seconded by Ross and an oral vote of 5 ayes to recognize the Supervisor's appointment of Gail Bentley as Deputy Town Supervisor, and set the annual salary for said position at \$2,000 to be paid monthly.

Motion by Wait, seconded by Jacangelo and an oral vote of 5 ayes, to set the annual salary for the four Council members (Gail Bentley, David Hass, June Ross and Michelle Wait at \$4,120 each, to be paid monthly.

Motion by Bentley, seconded by Wait and an oral vote of 5 ayes, to recognize the Supervisor's appointment of Michelle Asquith, as Secretary to the Town Supervisor, at an hourly rate of \$18.38, to be paid weekly.

Motion by Supervisor Jacangelo, seconded by Hass and an oral vote of 5 ayes to set the annual salary of the Town Clerk/Tax Collector, Susan Horton, at \$39,599.46 to be paid bi-weekly.

Motion by Ross, seconded by Bentley and an oral vote of 5 ayes, to appoint Susan Horton, Water Receivable Clerk at a yearly salary of \$3,000 to be paid bi-weekly, with a term to expire 12/31/15.
